- Burned out light in Continental Refrigerator 1079777 & 1006113, and Traulsen Refrigerator 653926. Replace lights.
- Dirty rusty fan above cash register on serving line. Remove rust; clean and disinfect fan.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.

Water temperature at hand wash sink 93°F. Ensure that temperature at hand wash sink attains a minimum temperature of 100°F.
